

**COOPERATION AGREEMENT BETWEEN THE DIPLOMATIC
ACADEMY OF PERU AND THE DIPLOMATIC ACADEMY OF THE
CZECH REPUBLIC**

The Diplomatic Academy of Peru and the Diplomatic Academy of the Czech Republic (hereinafter referred to as "the Contracting Parties"), desirous of promoting mutual cooperation in the fields of education, research and other related fields.

Have agreed as follows:

ARTICLE I

The Contracting Parties will make efforts to promote and expand their cooperation through the exchange of information on their respective study programs, courses, seminars, conferences, workshops and other academic activities.

ARTICLE II

The Contracting Parties will exchange information on the recruitment, education and training of Foreign Service officers of both countries, in the context of the process of globalization and it's consequences on international relations.

ARTICLE III

1. - The Contracting Parties will consult each other on the viability of organizing courses and seminars to be held alternately in Prague and Lima.
2. - The Contracting Parties will promote the exchange of professors, lectures, experts and researchers on areas of common interest.

ARTICLE IV

1. - The Contracting Parties will exchange, on a regular basis, publications and magazines concerning their specialties.
2. - The libraries of the Contracting Parties will establish a cooperative program to facilitate the exchange of information, articles and books.



ARTICLE V

The Contracting Parties will exchange information on activities of common interest, particularly those related to their participation in meetings and organizations for the education and training of diplomats.

ARTICLE VI

For the purpose of facilitating the above-mentioned exchange of information, the Contracting Parties will send the pertinent documentation for their perusal through the Internet or any other medium suitable to the objectives pursued. Corresponding coordination activities will be carried out in an expeditious and timely manner to achieve these objectives.

ARTICLE VII

All the activities under this Cooperation Agreement will be subject to the availability of appropriate funds and personnel and the laws and regulations of the respective countries of the Contracting Parties.

ARTICLE VIII

1. - This Cooperation Agreement will enter into force upon its signing
2. - This Cooperation Agreement will be valid for three (3) years and will be automatically renewed for successive periods of three (3) years unless one of the Contracting Parties notifies in writing the other of its intention to terminate it at least ninety (90) days before its expiry.
